The Belgian draft legislation was published in the TRIS database of the European Commission on 7 August 2023 under notification number 2023/0490/BE (Belgium) under the notification procedure under Directive 1535/2015/EU to inform Member States and the EU. The purpose of the draft Belgian cooperation agreement is to establish a national framework for certain waste streams covered by extended producer responsibility as set out in Directive (EU) 2019/904 on single-use plastic products.

The Slovak Republic submits the following detailed opinion on the matter.

The scope of the Belgian draft is not in line with Directive (EU) 2019/904 and also poses potential obstacles to the smooth functioning of the EU internal market.

Recital 16 of Directive (EU) 2019/904 explicitly states: 'Innovation and product development are expected to provide viable alternatives to filters containing plastic and need to be accelerated. Extended producer responsibility schemes for tobacco products with filters containing plastic should also encourage innovation leading to the development of sustainable alternatives to tobacco product filters containing plastic.'. In general, Directive (EU) 2019/904 aims to promote the development and use of available and more sustainable alternatives instead of plastic products.

In the light of the above, we consider that the draft Belgian national law to be adopted contains provisions that do not comply with the provisions of Directive (EU) 2019/904 are disproportionate, with a serious risk of creating unjustified obstacles to the free movement of goods in the internal market and distorting competition. The Belgian draft cooperation agreement requires manufacturers and importers of filtered tobacco products to pay extended producer responsibility fees, regardless of whether the products contain plastic or not. This is not in line with Articles 7 and 8 of Directive (EU) 2019/904, which require measures to reduce consumption and restrict the market depending on the content of plastics. By not distinguishing between filters on the basis of their plastic content, the Belgian draft may unintentionally infringe Article 34 of the Treaty on the Functioning of the European Union (TFEU), which prohibits measures which have similar consequences to quantitative restrictions on imports. This approach creates potential obstacles to the unrestricted movement of goods within the EU. In the accompanying recital of the Belgian TRIS Notice 2023/0490/BE, the Belgian Government even acknowledges the extension of the scope of products to be covered by Directive (EU) 2019/904, on the grounds that this will avoid discrimination between producers of packaging materials containing plastics and those that do not. However, this argument is not sufficient as other packaging waste materials in Belgium are already subject to pre-existing EPR requirements under the transposed Packaging Waste Directive and the addition of non-plastic packaging to the scope of transposition of the SUP Directive is not in line with its stated objective. The Belgian Government's intention to add non-plastic packaging to the transposition of Directive (EU) 2019/904 as part of the declared objective of preventing discrimination unintentionally creates a legislative overlap. This obscures the clear definition established by the Packaging Waste Directive, leading to potential confusion and regulatory problems for businesses. It essentially creates a superfluous layer of legislation for non-plastic packaging already regulated in Belgium by the Packaging Waste Directive.

For example, Hungarian manufacturing of plastic-free tobacco product filters and related exports are also negatively affected by the adoption of the Belgian draft legislation, as companies based in Hungary have already invested significantly in research and development of plastic-free solutions for tobacco filters. For this reason, we consider it

necessary to deliver a detailed opinion and request that Belgium amend those provisions in order to comply with the objectives set out in Directive (EU) 2019/904, as well as with the fundamental principles of free movement of goods and free competition.

The Belgian authorities are invited to consider the Slovak detailed opinion and it is proposed that the text of the draft Belgian cooperation agreement be amended.
