On 24 January 2025, a notification from the Kingdom of Spain concerning a legislative proposal for Royal Decree XXXX/XXXX of XX XXXXX amending Royal Decree 579/2017 of 9 June 2017 regulating certain aspects relating to the manufacture, presentation and marketing of tobacco and related products (hereinafter the 'draft legislation') was published in the TRIS database.

The draft legislation regulates certain aspects related to the manufacture and placing on the market of tobacco products and related products. Article 52(1)(a) of the draft legislation specifically prohibits the placing on the market, sale, distribution or offering free of charge of nicotine pouches containing more than 0.99 mg of nicotine per pouch.

I.

The Czech Republic considers that the proposed restrictive measure contained in Article 52(1)(a) of the draft legislation goes beyond the requirements contained in Directive No 2014/40/EU (hereinafter the 'Tobacco Directive'), which makes the draft legislation liable to create an unjustified obstacle to the free movement of goods within the meaning of Article 34 of the Treaty on the Functioning of the European Union.

The indicated amount of 0.99 mg nicotine per pouch is significantly less than the requirements in the other EU Member States that regulate pouches and where the maximum amount of nicotine is in the range of 12-20 mg/pouch. Nicotine pouches do not contain tobacco, do not burn, do not create smoke or ash. They are intended for smokers as an alternative to conventional cigarettes.

II.

In view of the mechanism and design of the product and the manner in which the products are consumed, a nicotine limit that is this low constitutes de facto prohibition of this category of tobacco products. The objectives of the draft legislation could be met by more appropriate, less restrictive measures. These may include appropriate warnings on product labels or restrictions on certain flavours.

III.

In the light of the above, the Czech Republic considers that the draft legislation contains provisions that may create disproportionate obstacles to the free movement of goods and significantly distort the business environment in the internal market and may thus be contrary to the Kingdom of Belgium's obligations under EU law, as it contains measures that go beyond the Tobacco Directive and are disproportionate to the objective set out in the Tobacco Directive.
