released into a non-blocking state after an accepted breath sample has been presented and analysed for alcohol concentration.

Article 7. The installation and removal of the alcohol interlock devices;

Article 8 Verification of the correct operation of the alcohol interlock device.

9. The regulatory measure is necessary to implement the provisions of Article 125(3-ter) of Legislative Decree No. 285 of 30 April 1992, which regulates the characteristics of the alcohol interlock device, the methods of installation and the workshops authorised to install it.
