6. The Commission services thank the French authorities for the replies to the request for supplementary information of 5 June 2025.

In their replies, the French authorities note that the notified draft refers to services such as (i) core platform services, listed in Article 2 of Regulation (EU) 2022/1925. The Commission services would welcome further clarification on the intended interplay between the notified draft and Regulation (EU) 2022/1925, in particular:

1. Whether the notified draft introduces any obligations on providers of core platform services listed in Article 2(2) of Regulation (EU) 2022/1925. If yes, could the French authorities explain the necessity of such measure in view of the harmonization effect of this Regulation.
2. Whether the notified draft gives specific supervisory and enforcement powers to PEReN in relation to Regulation (EU) 2022/1925. If yes, which are these powers and the interplay of these powers with the cooperation framework laid down in Articles 37 and 38 of Regulation (EU) 2022/1925."

The French authorities are kindly asked to reply by 20 June 2025.
