Decree of

on the criteria, sub-criteria and rating system for the calculation and display of the durability index for household washing machines.

NOR: TRED2023820A

Targeted Audience: producers, importers, distributors or other marketers of household washing machines and sellers of the same equipment, as well as those using an online website, platform or other online distribution channel in the course of their commercial activity in France.

Subject: criteria, sub-criteria and rating system for calculating and displaying the durability index of household washing machines.

Entry into force: the text shall enter into force 6 months after its date of issue.

Notice: this Decree lays down the rating system for the washing machine durability index.

The Minister for Ecological Transition and Territorial Cohesion and the Minister of Economy, Finance and Industrial and Digital Sovereignty;

Having regard to Commission Regulation (EU) 2019/2023 of 1 October 2019 laying down ecodesign requirements for household washing machines and household washer-dryers pursuant to Directive 2009/125/EC of the European Parliament and of the Council, amending Commission Regulation (EC) No 1275/2008 and repealing Commission Regulation (EU) No 1015/2010;

Having regard to the Environmental Code, in particular Article L. 541-9-2 thereof;

Having regard to Decree No. of on the detailed rules for the application of the durability index for electrical and electronic products, its criteria and method of calculation,

Hereby order:

Article 1

This Decree shall apply to household washing machines falling within the scope of the Regulation of 1st October 2019 above.

Article 2

Pursuant to Articles R 541-210 to R. 541-214 of the Environmental Code, the criteria, sub-criteria and rating system applicable to the products defined in Article 1 for the calculation of the model durability index are specified in Annexes I and II to this Decree.

Article 3

Producers or importers of the equipment referred to in Article 1 shall place online the data referred to in Article R.541-236 of the Environmental Code on the single interministerial portal intended to collect and make available public information, referred to in Article 6(4) of Decree No 2019-1088 of 25 October 2019 on the State's Information and Communication System and the Interministerial Digital Directorate (www.data.gouv.fr) in accordance with the terms of the open licence for the re-use of public information referred to in Article D323-2-1 of the Code of relations between the public and the administration, as defined in the document available on https://www.etalab.gouv.fr/wp-content/uploads/2017/04/ETALAB-Licence-Ouverte-v2.0.pdf, allowing free re-use of this data.

Article 4

The Decree of 29 December 2020 on the criteria, sub-criteria and rating system for calculating and displaying the repairability index of front-load household washing machines and the Decree of 22 April 2022 on the criteria, sub-criteria and rating system for the calculation and display of the repairability index of top-load household washing machines are repealed.

For models placed on the market before the entry into force of this Decree and which are no longer re-marketed from this date, the repairability index must be displayed up to the last unit of the model sold.

Article 5

The provisions of this Decree shall enter into force 12 months after its date of issue.

For product models placed on the market after the entry into force of this Decree, the data referred to in Article 3 shall be placed online no later than one month after the first unit has been placed on the market.

For models placed on the market before the entry into force of this Decree and which continue to be placed on the market by the producer or importer, the data referred to in Article 3 shall be posted online no later than 3 months after the entry into force of this Decree.

Article 6

The Commissioner-General for Sustainable Development and the Director-General for Competition, Consumer Affairs and Fraud Control shall each be responsible for the implementation of this Decree, which shall be published in the *Official Journal* of the French Republic.

For the award of points, the commercial durability guarantee is free of charge and must favour the repair of goods over the replacement of the products concerned. In addition, non-conformities which appear during the period of commercial durability guarantee, including for goods with digital elements, shall, unless proven otherwise, be presumed to have existed at the time of delivery, unless such presumption is incompatible with the nature of the goods or of the defect claimed.

Sub-criterion 3.2. Setting up a quality process

This criterion refers to the setting up within the company of a documented and demonstrable continuous improvement process, at the request of the public authorities in the event of an inspection, to increase the durability of each product model placed on the market, through monitoring and improvement of products.

To obtain the points, the manufacturer must be able to show all of the following:

- That faults are identified and monitored by the technical departments of the manufacturer or its subsidiaries Supporting statistics;
- That these failures are documented through structured and systematic reporting back to central departments (Technical/Quality/R&D);
- That these reports are taken on board and processed by the R&D departments with concrete changes to the products in order to constantly improve their reliability and durability;
- That the changes made are then traced and their impacts measured statistically to demonstrate the effectiveness of the improvements made.
