6. Within the framework of the notification procedure laid down by Directive (EU) 2015/1535, the French authorities notified to the Commission on 24 February 2025 the draft "Proposal for a Decree on the prohibition of products for oral use containing nicotine" (hereinafter, 'the notified draft').

In order to allow the Commission services to complete their analysis under the relevant provisions of EU law, the French authorities are kindly invited to reply to the following request for supplementary information.

According to Article 1 of the notified draft text Section II of Chapter II of Title III of Book I of Part Five of the Public Health Code is to be supplemented by Subsection 6, which, among other prohibitions, bans the "transport", "import", and "export" of products for oral use containing nicotine. In this context, could the French authorities please clarify whether the notified draft measure is designed to apply to the importation and exportation to other Member States and/or third countries as well as to transit operations involving other Member States and/or third countries?

The French authorities are kindly invited to reply by 14 April 2025.
