Order of 16 July 2025 amending two orders relating to the environmental score determining eligibility for certain aid for the purchase or rental of low-polluting vehicles

NOR: TECR2520245A

Parties concerned: *purchasers and leasers of vehicles; automotive professionals.*

Subject: *update of the list of versions of electric passenger cars that have reached the minimum environmental score referred to in Article D. 251-1 of the Energy Code, laid down by the order of 14 December 2023, which are therefore eligible for certain financial assistance for the purchase or leasing of low-emission vehicles under this criterion; modification of the reference to the environmental score in the Energy Code in two orders relating to the environmental score.*

Entry into force: *this Order shall enter into force on the day after its publication.*

Application: *this Order, adopted pursuant to Articles D251-1 and D251-1-A of the Energy Code, can be consulted on the Légifrance website (<http://www.legifrance.gouv.fr>).*

The Minister for the Economy, Finance and Industrial and Digital Sovereignty, the Minister for Spatial Planning and Decentralisation and the Minister for the Ecological Transition, Biodiversity, Forests, Marine Affairs and Fisheries,

Having regard to Directive (EU) 2015/1535 of the European Parliament and of the Council of 9 September 2015 laying down a procedure for the provision of information in the field of technical regulations and of rules on Information Society services;

Having regard to the Energy Code, in particular Articles D251-1 to D251-13 thereof;

Having regard to the Order of 14 December 2023, as amended, laying down the list of versions of electric passenger cars that have achieved the minimum environmental score required to be eligible for certain financial assistance for the purchase or leasing of low-emission vehicles;

Having regard to the Order of 7 October 2023 on the methodology for calculating the environmental score and the minimum score value to be achieved for new electric passenger cars to be eligible for the ecological bonus;

Having regard to notification no. 2025/**X**/FR addressed to the European Commission on 16 July 2025,

Hereby order:

Article 1

Article 1 of the aforementioned Order of 14 December 2023 is amended as follows:

1° In paragraph 1 of Article 1, the words: “c of 6° of I are replaced by the word: “3°”;

2° In the first column of the first table, the word: “DS” shall be replaced by the words: “DS AUTOMOBILES”;

3° In the three hundred and forty-fourth and three hundred and forty-fifth rows of the first table, the word: “FIAT” is replaced by the word: “ABARTH”;

4° At the end, the following provisions are added:
