6. Belgium's legislative proposal was posted on the European Commission's TRIS database on 25.4.2023 under notification number 2023/0215/B (Belgium), as part of the notification procedure according to Directive 1535/2015/EU, to inform the Member States and the EU.

The purpose of the draft Belgian Royal Decree on the manufacture and placing on the market of tobacco products and herbal smoking products is to transpose into Belgian national legislation Commission Delegated Directive (EU) 2022/2100 of 29 June 2022 amending Directive 2014/40/EU of the European Parliament and of the Council as regards the withdrawal of certain exemptions in respect of heated tobacco products.

In this Belgian legislative proposal, in Article 2 "Definitions", the definition of heated tobacco product is added, based on the definition set out in Delegated Directive 2022/2100, as follows: "heated tobacco product: a new tobacco product that is heated to produce an emission containing nicotine and other chemicals, which is then inhaled by users."

However, this definition deviates from the definition of heated product in Delegated Directive (EU) 2022/2100, which is given in Article 1(1) of the Directive with the following wording: "'heated tobacco product' means a novel tobacco product that is heated to produce an emission containing nicotine and other chemicals, which is then inhaled by user(s), and that, depending on its characteristics, is a smokeless tobacco product or a tobacco product for smoking."

Belgium's legislative proposal changes the definition of heated product by omitting the last part of the definition: "...and that, depending on its characteristics, is a smokeless tobacco product or a tobacco product for smoking" and is contrary to the provisions of Article 1 and recital 4 of the Delegated Directive on heated tobacco products because it does not include the specific characteristics of heated tobacco products, equating them with conventional cigarettes.

In addition, Article 11 of the submitted Royal Decree provides that all heated tobacco products (including smokeless tobacco products) are considered to be tobacco products for smoking and must comply with the same provisions on combined health warnings (text and photograph) as conventional cigarettes. This is an incorrect transposition of the Delegated Directive, which again attempts to equate heated tobacco products with conventional cigarettes.

In view of the above, it is the opinion of our department that the national Belgian draft law to be adopted contains provisions that are not in line with the provisions of Delegated Directive (EU) 2022/2100, are disproportionate, with a serious risk of creating unjustified barriers to the free movement of goods in the internal market and distortion of competition.

As a result of the Belgian legislative proposal to be adopted, Greek tobacco production, Greek tobacco industry and related Greek exports are negatively affected, as Greek companies have already invested in the manufacture of new heated tobacco products which are exported worldwide.

For the above reasons, we consider it necessary to submit a Detailed Opinion. In view of the above, we request that the above provisions be amended by Belgium, so as to be in line both with the objectives of public health protection and the fundamental principles of free movement of goods and free competition, within the framework of Commission Delegated Directive (EU) 2022/2100 of 29 June 2022 amending Directive 2014/40/EU of the European Parliament and of the Council as regards the withdrawal of certain exemptions in respect of heated tobacco products.
