This will support the protection of public health and will help inform consumers about the food's suitability for its intended purpose. The draft Regulation will facilitate the operation of food enterprises involved in the handling of food by setting clear conditions regarding the prohibition of the use of certain plants and parts of plants in food (in food supplements, herbal teas, syrups, extracts, mixed seasonings and other products)
