8. The guidance consists of two distinct parts as a destination:

- part I, DESIGN, which deals with the issues related to works sizing and composition;
- part II, EXECUTION, which deals with the conditions and technologies for carrying out the works.

9. The scope of this guidance is the design and execution of works to protect and reinforce wet embankments for water transport channels (waterworks, irrigation, drainage) and flood barriers (outdoor embankments). It is developed in order to guide the design and execution of these works.

This guidance does not have an exhaustive content, its purpose is to present the main issues of this type of works, the most common constructive solutions, being up to the designer, depending on the specific situation, to design other solutions or provide for the use of other materials, while ensuring the stability and efficiency of the work.

For the purposes of this guide, reinforcement refers to the reinforcement of the bed section and wetted slopes to ensure stability and strength. Reinforcements to rehabilitate degraded or damaged portions and maintenance are not covered by this guidance. For these works, another guidance is recommended.

Also, throughout the guidance, the term dikes refers to flood defence dams.
