5. Draft Ministerial Order establishing the criteria for determining when plastic waste undergoing mechanical treatment and destined for the manufacture of plastic products ceases to be waste pursuant to Law 7/2022 of 8 April on contaminated waste and soils for a circular economy.

6. Certain plastic waste (specifically thermoplastic waste) which is mechanically treated and which, once meeting the



end-of-waste criteria defined in the order, will no longer be considered as waste.

7. - Directive (EU) 2015/1535 of the European Parliament and of the Council of 9 September 2015 laying down a procedure for the provision of information in the field of technical regulations and of rules on information society services.

8. This Ministerial Order, which is valid throughout the territory of the State, lays down the requirements to be met by thermoplastic waste eligible for mechanical treatment, the requirements to be met by such recovery treatments, the quality criteria to be met by the resulting material after the recovery operation in line with the applicable product standards, as well as the procedure for verifying compliance with end-of-waste criteria through management systems. All this for the purpose of mechanically treated thermoplastic waste is no longer considered waste.

9. This is a flow that currently does not have a single regulatory framework at European Union level.

The European Commission commissioned the Joint Research Centre-Joint Research Centre to study the proposed end-of-waste criteria for certain plastic waste, including all the basic information required to ensure compliance with the terms of Article 6 of Directive 2008/98/EC of 19 November. This study was published in 2014, however, to date, no legislative initiative has yet taken place by the European Commission with the aim of establishing these end-of-waste criteria.

Given the importance of this waste stream and the absence of regulation at EU level, the development of these criteria for plastic waste at national level, as foreseen in Article 6 of Directive 2008/98/EC of 19 November, has been considered necessary.
