Decree No 2019-1451 of 24 December 2019 on the prohibition of certain single-use plastic products

The Prime Minister,

On the report of the Minister for the Ecological and Inclusive Transition and the Minister for Economy and Finance,

Having regard to Directive No 94/62/EC of the European Parliament and of the Council of 20 December 1994 on packaging and packaging waste, notably amended by Directive 2004/12/EC of the European Parliament and of the Council of 11 February 2004;

Having regard to Directive (EU) 2015/1535 of the European Parliament and of the Council of 9 September 2015 laying down a procedure for the provision of information in the field of technical regulations and of rules on Information Society services;

Having regard to Directive 2019/904 of the European Parliament and of the Council on the reduction of the impact of certain plastic products on the environment;

Having regard to Directive 90/385/EEC on the approximation of the laws of the Member States relating to active implantable medical devices;

Having regard to Directive 93/42/EEC concerning medical devices;

Having regard to the Environmental Code, especially Article L541-10-5(III) thereof, introduced by Article 73 of Law No 2015-992 of 17 August 2015 on energy transition for green growth and amended by Article 28 of Act No 2018-938 of 30 October 2018 to balance trade relationships in the agricultural and food sector and provide food which is healthy, sustainable and accessible to all;

Having regard to the observations made during the public consultation carried out between 24 July 2019 and 3 September 2019, pursuant to Article L. 123-19-1 of the Environmental Code;

Having regard to notification No 2019/0346/F sent to the European Commission on 18 July 2019,

Hereby decrees:

Article 1

Article 4

The provisions of this decree shall enter into force on 1 January 2020, with the exception of the provisions of Article 3, which shall enter into force on 3 July 2021.

Straws, cutlery, steak skewers, disposable glass lids, meal trays, ice cream cups, salad bowls, boxes and stirrers for beverages subject to a prohibition on making available, as from 1 January 2020, pursuant to III of Article L. 541-10-5, shall have a period of disposal of stocks of those products not exceeding six months from that date, provided that they were manufactured or imported before that date.

Article 5

The Minister for the Ecological and Inclusive Transition, the Minister for the Economy and Finance, the Secretary of State to the Minister for Ecological and Solidarity Transition and the Secretary of States to the Minister for Economy and Finance shall be responsible, insofar as it falls within their remit, for

implementing this decree, which shall be published in the Official Journal of the French Republic.
