- The purpose of the draft is to transpose the obligations imposed by the Directives referred to in point 9 into national law, thereby increasing the reuse of packaging, recycling or other recovery of packaging waste and preventing and

reducing the impact of certain plastic products on the environment, in particular on the aquatic environment and on human health.

8. The Government Decree contains detailed rules related to the mandatory deposit return scheme.

Products with a mandatory deposit fee include the consumer packaging of beverage products ready for consumption or concentrate, excluding specified milk and milk-based beverage products, where such packaging consists of plastics, metals or glass and comes in the form of bottles or cans, either reusable or non-reusable, of a capacity of 0 to 6 litres. In order to encourage the public to return their bottles and cans and to finance the deposit return scheme, the draft provides for the refund of the deposit for products with a compulsory deposit fee. Consumers are entitled to a refund of the deposit if they return the product in a specified condition to the bottle bank.

A product with a voluntary deposit fee is a specific product or packaging not included among the above products, which is manufactured or placed on the market by the manufacturer voluntarily with the indication 'returnable' and the production or placing on the market with this marking has been notified to the national waste management authority.

9. Directive (EU) 2018/852 of the European Parliament and of the Council of 30 May 2018 amending Directive 94/62/EC on packaging and packaging waste requires Member States to take measures to increase the share of reusable packaging on the market and the number of packaging reuse systems. These measures include, inter alia, the use of deposit refund schemes and the setting of targets. Directive (EU) 2019/904 of the European Parliament and of the Council of 5 June 2019 on the reduction of the impact of certain plastic products on the environment requires Member States to meet a target for certain single-use plastic products, which can be achieved by introducing a deposit fee. In view of this, it is necessary to introduce and operate a mandatory deposit refund scheme under extended producer responsibility schemes.

Directive (EU) 2018/851 of the European Parliament and of the Council of 30 May 2018 amending Directive 2008/98/EC on waste requires Member States to take specific measures to prioritise prevention and recycling against landfilling and waste incineration, including deposit return schemes and other measures to encourage the efficient collection of used products and materials.

The aim of the draft is to transpose the obligations imposed by the above directives in national law, thereby increasing the reuse of packaging, recycling or other recovery of packaging waste and preventing and reducing the impact of certain plastic products on the environment, in particular on the aquatic environment and on human health.
