EXPLANATORY MEMORANDUM

Pursuant to Article 4(a)(2) of the Law on the prevention of the abuse of chemical substances (Wvmc), the designation of substances the import, export, transport or possession of which is prohibited under Article 4(a)(1) of the Wvmc is carried out by Ministerial Regulation of Our Minister of Justice and Security, also on behalf of Our Minister of Health, Welfare and Sport. This Decree designates those substances referred to in Article 4(a)(1) of the Wvmc.

When this list was drawn up, it was coordinated with the members of the Expert Group on Drug Precursors [Expertgroep drugsprecursoren], which was established with the Institutional Policy Expert Group on Drug Precursors [Instellingsbeleid Expertgroep drugsprecursoren]. The substances designated by this Regulation are assessed in accordance with the conditions laid down in Article 4(a)(2) of the Wvmc. The coordination with the members of the Expert Group ensures that the designation was done carefully, that the substances can be used for the illicit manufacture of narcotic drugs or psychotropic substances and that no legal application of the substances is known.
