## ORDER

AMENDING ORDER NO 3-301 OF THE MINISTER OF TRANSPORT AND COMMUNICATIONS OF THE REPUBLIC OF LITHUANIA OF 4 JULY 2005 APPROVING THE RULES FOR THE REGISTRATION OF SEAGOING SHIPS OF THE REPUBLIC OF LITHUANIA

- 1. I hereby amend the Rules for the registration of seagoing ships of the Republic of Lithuania approved by Order No 3-301 of the Minister of Transport and Communications of the Republic of Lithuania of 4 July 2005 approving the Rules for the registration of seagoing ships of the Republic of Lithuania:
  - 1.1. Sub-paragraph 2.6 is added:
- "2.6. Ships over 25 years of age that are engaged in international voyages (when seeking registration in the register for the first time), the year of construction of which is indicated in a document certifying the class of the vessel issued by a recognised organisation or a competent authority of a Member State of the European Union or of another State of the European Economic Area (hereinafter referred to as "Member State") or a body authorised by it. This provision shall not apply to fishing vessels, reefer vessels and vessels flying the flag of a Member State, provided that the Member State is on the White List of the Paris Memorandum of Understanding on Port State Control in the last three years preceding the submission of the vessel's registration documents to the Administration."
  - 1.2. I do hereby amend sub-paragraph 6.6 to read as follows:
- "6.6. a copy of a document certifying the class of the vessel issued prior to the transfer of the vessel by a recognised organisation or a competent authority of a Member State or a body authorised by it;".
  - 2. I hereby l a y d o w n the following:
- 2.1. This technical regulation complies with the requirements of Directive (EU) 2015/1535 of the European Parliament and of the Council of 9 September 2015 laying down a procedure for the provision of information in the field of technical regulations and of rules on Information Society services.
- 2.2. Paragraph 1.1 of this Order shall enter into force after the standstill period laid down in paragraph 15 of the Rules for the provision of information in the field of technical regulations and conformity assessment procedures approved by Resolution No 617 of the Government of the Republic of Lithuania of 20 May 1999 approving the Rules for the provision of information in the field of technical regulations and conformity assessment procedures.
- 2.3. Following the entry into force of paragraph 1.1 of this Order, the Water and Railway Transport Policy Group of the Ministry of Transport and Communications shall immediately notify the Registrar of the Register of Legal Acts.
