8. The legislative decree provides an administrative framework for testing with self-driving motor vehicles.

The decree includes, inter alia, provisions on the following:

- Testing must be carried out with self-driving motor vehicles up to level 4 in accordance with SAE standard J3016.
- There must be a designated person with responsibility for each test.
- Whether the vehicle is driven manually or automatically must be registered.
- The type of information that must be included with an application.
- Penalties in connection with testing.

9. The objective of this legislative decree is to establish the overall framework and conditions for conducting testing with self-driving motor vehicles on roads that are accessible to regular traffic.
