The proposed legislation amends the provisions of the Legislative Decree transposing Directive 2019/904 (SUP) in order to provide detailed technical characteristics to ensure the reusability of certain products listed in the Annex, Part B, which are prohibited from being placed on the market pursuant to Article 5 of the same Legislative Decree. The objective of the proposed technical rule is to define the technical requirements for the reusability of the above-mentioned plastic products for their placing on the market in order to ensure the correct application of the SUP Directive and to avoid the marketing of products labelled as reusable but perceived and used by consumers as disposable.

9. In supranational legislation there are no specific provisions containing the technical characteristics to define a plastic product as reusable under the SUP Directive. This situation, according to the operators, raises critical issues regarding how to clearly identify plastic products that are reusable as opposed to disposable.
