The provisions on self-monitoring programmes for tobacco-free nicotine products shall be regulated in the same way as the self-monitoring programmes for tobacco products, electronic cigarettes and refill containers. The regulations regulate the content of the self-monitoring programme for retail, when the trader has their registered office or fixed place of business in Sweden, or for distance selling from another country to Sweden. The proposal provides for minimum requirements for the content of a self-monitoring programme and that it should be kept up to date. The procedures in a self-monitoring programme shall describe, among other things, how the trader ensures that the products are notified, correctly labelled, that advertising and marketing comply with the requirements of the law and that they are not sold or otherwise made available to persons under the age of 18.

9. The purpose of the regulations is to supplement the associated Act and Ordinance and, by doing so, contribute to strengthening the protection of human health. The Public Health Agency of Sweden's assessment is that the provisions are necessary and proportionate.
