6. Detailed Opinion on TRIS Notification of the Kingdom of Belgium 2023/0490/BE

On 7 August 2023, a notification by the Kingdom of Belgium concerning a legislative proposal for a Cooperation Agreement on a framework for extended producer responsibility for certain waste streams and for litter (hereinafter the 'draft regulation') was published in the TRIS database.

The main objective of the draft regulation is to establish a national framework with regard to certain waste streams covered by extended producer responsibility and thus to transpose certain provisions of Directive (EU) 2019/904 on the reduction of the impact of certain plastic products on the environment (hereinafter the 'SUP Directive').

I.

The Czech Republic considers that the proposed wording of Article 8 of the draft regulation, which requires manufacturers and importers of tobacco products with filters to pay fees for extended producer responsibility, whether or not the products contain plastic, goes beyond the requirements contained in the SUP Directive, which makes the draft legislation liable to create an unjustified obstacle to the free movement of goods within the meaning of Article 34 of the Treaty on the Functioning of the European Union.

II.

The SUP Directive explicitly states in recital 16 of the preamble that innovation and product development are expected to provide viable alternatives to plastic-containing filters and need to be accelerated. Extended producer responsibility schemes for tobacco products with plastic-containing filters should also foster innovation leading to the development of sustainable alternatives to plastic-containing tobacco product filters. Thus, one of the stated objectives of the SUP Directive is generally to promote the development and use of available and sustainable alternatives to plastic products.

Article 9 of the draft regulation states that 'Extending the scope of the levy to products not approved by the SUP Directive is necessary in order to avoid discrimination between manufacturers. In principle, it is indefensible to exclude producers or group of producers whose packaging is largely found in waste from extended producer responsibility, since the SUP Directive focuses only on plastic packaging waste.' The accompanying justification for the notification also justifies extending the scope of products covered by the SUP Directive by avoiding discrimination between producers of packaging materials containing plastic and those not containing them.

We consider that the above argument has no legal relevance, because a certain degree of positively understood discrimination focusing primarily on products containing plastic, which reflects the compromise reached in the legislative process, is already contained in the provisions of the SUP Directive. Thus, the EU rules contained in the SUP Directive already place plastic products at a "disadvantage" because of their environmental impact, by imposing more requirements on them than on others. It should be noted that it even directly prohibits certain types of products.

III.

In the light of the above, the Czech Republic considers that the draft legislation contains provisions that may create disproportionate obstacles to the free movement of goods and significantly distort the business environment in the internal market and may thus be contrary to the Kingdom of Belgium's obligations under EU law, as it contains measures that go beyond the SUP Directive and are disproportionate to the objective set out in the SUP Directive.
