Pursuant to Article 65(4) of the Agriculture Act (Official Gazette of the Republic of Slovenia Nos 45/08, 57/12, 90/12 — ZdZPVHVVR, 26/14, 32/15, 27/17, 22/18, 86/21 – Constitutional Court decisions 123/21, 44/22 and 130/22 – ZPOmK-2, 18/23 and 78/23), the Minister of Agriculture, Forestry and Food, in agreement with the Minister of Economic Development and Technology, issues the following

RULES

on amendments and additions to the Rules on ensuring the traceability of origin for nonprepacked fresh, chilled and frozen beef, pork, sheep, goat and poultry meat

Article 1

In the Rules on ensuring the traceability of origin for non-prepacked fresh, chilled and frozen beef, pork, sheep, goat and poultry meat (Official Gazette of the Republic of Slovenia Nos 54/22 and 106/23), a comma and the words 'except a retail invoice' are added after the word 'document' in Article 4(2).

Article 2

Article 5 is amended to read as follows:

'Article 5

(1) Operators must comply with the requirements of these Rules by 1 March 2024 at the latest.

(2) For the purposes of indicating the country of origin or place of provenance of the meat referred to in the first paragraph of the preceding Article of these Rules, operators shall use the designation referred to in Annex 1, which is an integral part of these Rules, on the retail invoice, but not later than 31 October 2025. The designation referred to in Annex 1 does not need to be indicated on a retail invoice issued using a cash register.'.

Article 3

A new Annex 1 is added, which is an integral part of these Rules.

FINAL PROVISION

Article 6

(Entry into force)

These Rules enter into force on the fifteenth day after their publication in the Official Gazette of the Republic of Slovenia.
