Within the framework of the notification procedure under Directive (EU) 2015/1535 laying down a procedure for the provision of information in the field of technical regulations and of rules on Information Society services, the Spanish authorities notified to the Commission on 16 February 2024 the "Resolution approving the data model of the information monitoring system and amending the annexes on technical specifications and on identification and subjective prohibitions on participation in gambling activities" (hereinafter, the "notified draft").

In order to allow the Commission services to complete their analysis under the relevant provisions of EU law, the Spanish authorities are kindly invited to reply to the following request for supplementary information:

- The Commission would like to request clarifications on the definition of third parties providing professional identity verification services.

- In addition, the Commission would kindly request clarification on whether the MS foresees a certification scheme for or a list of requirements which identity verification services should meet in order to support operators in choosing an acceptable third party and consequently demonstrating compliance with the Section 2.1.5.

The Spanish authorities are kindly invited to reply by 22 March 2024.
