On the procedure for including fertilising products that are placed and made available on the market of the Republic of Lithuania in the identification list and removing them from this list, and on the approval of the identification list of fertilising products that are placed and made available on the market of the Republic of Lithuania

6. Placing fertilising products on the market and making fertilising products available on the market.

8. The draft order shall lay down the procedure for including fertilising products placed and made available on the market of the Republic of Lithuania in the fertilising products identification list and for removing them from that list. The draft Order also approves the identification list of fertilising products placed and made available on the market of the Republic of Lithuania ('the identification list'). The identification list sets out the specific safety and quality requirements for fertilising products made available on the market of the Republic of Lithuania.

9. The draft Order is designed to remove stricter requirements than EU legislation by aligning unwanted impurities and their maximum permissible levels with Regulation (EU) 2019/1009 of the European Parliament and of the Council of 5 June 2019 laying down rules on the making EU fertilising products available on the market and amending Regulations (EC) No 1069/2009 and (EC) No 1107/2009 and repealing Regulation (EC) No 2003/2003. Testing for chromium and selenium has been waived and testing for enterococci bacteria is foreseen instead of testing for enterococcaceae family bacteria; and the functional category of fertilising products and their general quality and safety requirements have been aligned with the specific safety and quality requirements for fertilising products. Technical changes have been made.
