5. Draft Rules on fruit jams, jellies, marmalades, preserves and sweetened chestnut purée

6. These Rules transpose into the legal framework of the Republic of Croatia provisions of Council Directive (EU) 2001/113/EC of 20 December 2001 relating to fruit jams, jellies and marmalades and sweetened chestnut purée intended for human consumption (OJ L 10, 12.1.2002).

8. These Rules lay down requirements in the production and placement on the market that must be met by fruit jams, jellies, marmalades, preserves and sweetened chestnut purée intended for consumption, which apply to:

- names, definitions and general requirements
- composition and organoleptic characteristics
- type and quantity of source materials and other ingredients used in their production and processing, and
- additional labelling requirements.

The provisions of these Rules do not apply to products intended for the production of bakery, fine bakery and related products which are defined in a special regulation on cereals and cereal products.

9. The Rules on fruit jams, jellies, marmalades, preserves and sweetened chestnut purée (Narodne Novine (NN; Official Gazette of the Republic of Croatia) No 94/11) transpose into the legal framework of the Republic of Croatia provisions of Council Directive (EU) 2001/113/EC of 20 December 2001 relating to fruit jams, jellies and marmalades and sweetened chestnut purée intended for human consumption (OJ L 10, 12.1.2002).

The new draft Rules on fruit jams, jellies, marmalades, preserves and sweetened chestnut purée which transpose the Council Directive (EU) 2001/113/EC of 20 December 2001 relating to fruit jams, jellies and marmalades and sweetened chestnut purée plan to introduce a national measure which is enabled by this Directive.

The national measure is related to products referred to in Article 1, paragraph 1 of the Rules which have reduced sugar content and may be placed on the market under names provided in Annex 1 to the Rules, provided that they include a minimum 55 % of soluble solids.

High sugar content is not in line with existing trends in product development and reduced energy content of food. Lower sugar content also allows manufacturers to shorten the cooking time of these products, which results in increased product quality.

In addition, the new draft Rules revise the legislation referred to in the Rules, as the previous Rules (NN No 94/11) were developed before Croatia's accession to the EU.
