Annex A: features, requirements and procedures for type approval, calibration and verification of functionality of devices and systems for detecting violations of maximum speed limits pursuant to Article 142 of the Highway Code.

Annex B: list of devices and systems which, approved in accordance with Ministerial Decree 282/2017, are to be considered type-approved as they comply with the provisions of Chapter 1 of Annex A.

9. The purpose of the measure is the approval of devices and systems, including in this process all calibration and functionality checks carried out during the three phases of the life cycle of these devices:

- prototype approval;
- calibration and initial functionality serviceability checks of individual devices and systems;
- calibration and periodic serviceability checks of individual devices and systems.

While the requirements and tests required for the approval of devices or systems are in line with the provisions of Ministerial Decree 282/2017, it has been clarified that the approval process will be strengthened by requiring manufacturers to obtain quality certification (ISO 9001) and the possibility of conducting inspections by bodies authorised by the Ministry, previously accredited by Accredia, in order to ensure that the conformity of each individual device and system produced is as close as possible to the approved prototype.
