Within the framework of the notification procedure under Directive (EU) 2015/1535, the Dutch authorities notified to the Commission on 16 February 2026 the draft 'Regulation of the Minister for Agriculture, Fisheries, Food Security and Nature amending the Fertilisers Act Implementation Regulation in connection with the conditional authorisation of Renure beyond the application standards for animal manure' (hereinafter, "the notified draft").

In order to allow the Commission services to complete their analysis under the relevant provisions of EU law, the Dutch authorities are kindly invited to reply to the following request for supplementary information:

- the Dutch authorities indicate their intention not to carry out ongoing testing of mineral concentrations as regards their compliance with the limit for pathogens set out in point (iv) of the new provisions, nor of their organic carbon content, the stated reason being that "mineral concentrate from reverse osmosis normally contains less than 1% organic carbon". However, the Dutch authorities indicate that the organic carbon content may evolve over time and that they intend to continue monitoring this. The Commission notes the importance of ensuring a consistently high quality standard for RENURE materials and would request further information on this point.

- In addition, this TRIS notification concerns the implementation in The Netherlands of the new provisions of the Nitrates Directive introduced by Commission Directive (EU) 2026/288 of 9 February 2026 amending Council Directive 91/676/EEC as regards the use of certain fertilising materials from livestock manure. The Commission would like to underline that the application of these new provisions (i.e. the application of RENURE materials above the livestock manure limit) is only possible once a Member State has implemented all the conditions set out in the new provisions. The Commission notes that some of these elements are not included in this TRIS notification, such as the conditions related to livestock density and application methods. The Commission would welcome further information from the Dutch authorities on the
