6. Request for supplementary information in accordance with Article 5, paragraph 2, of Directive (EU) 2015/1535):

Denmark fully supports measures and initiatives that encourage responsible drinking and the restriction on advertising of alcohol targeted minors as laid out in the notified draft 'the Belgian Royal Decree on advertising of beverages containing alcohol'.

However, Denmark finds that there is lack of information and clarification in the notified draft which could potentially lead to barriers on the Single Market and moreover makes it difficult for Member States and the Commission to assess the impact of the notified draft.

Therefore, Denmark requests additional information within the following:

Scope and application: In Article 1 of the Decree, it is laid out that 'the affixing of a mark or logo shall also be regarded as advertising'. However, the application and scope of a mark or logo isn't further defined or explained in the Decree. Therefore, Denmark requests further information related to the application and definition of the 'affixing of a mark or logo' and thereby the products concerned.

Entry into force: There is no information on the entry into force date or period in the notified draft or if a transition period applies. Therefore, we would request that the Belgian Government provide information on the expected date of entry into force, date of application, and a possible transition period.

Health Information Message: Article 7 concerns provisions on health information messages, which should be solely laid down by the Minister. However, this Article doesn't state the intended wording of such health information message and therefore Denmark requests additional information regarding the wording of the health message.

Denmark welcomes a response with supplementary information on the notified draft, and request that this information is provided in the TRIS-database before the end of the standstill period on 22nd of April 2024.
