6. Finland has notified the Commission of the Government proposal for an Act amending the Alcohol Act (Notification 2024/387/FI). However, changes have been made to the proposal since then due to feedback received from consultation. The main change relates to the limits on the alcoholic strength of alcoholic beverages delivered in retail trade. By way of derogation from the previous proposal, Finnish microbreweries and vineyards would be allowed to deliver their farm wines and beers directly to the delivery address indicated by the consumer, up to the percentage limit approved for their retail sale.

As this amendment extends the scope of the Act, a new notification of the proposal will be made.
