6. We refer to the notification in question to indicate that the notified draft technical regulation does not provide for mutual recognition clauses.

This is in breach of Article 34 of the Treaty on the Functioning of the European Union ('TFEU') on the free movement of goods in the internal market of the EU.

The measure proposed by Denmark therefore forecloses the Danish market to nicotine pouches legally produced and sold in other Member States. By effectively banning these products, the proposed measure undermines the principle of mutual recognition in the internal market and creates unjustified barriers to trade.
