14. Regulation: **Viennese Structural Engineering Regulation 2023 – WBTv 2023 [CELEX
No.: 32010L0031, 32013L0059 and 32018L0844]**

Regulation of the Vienna State Government, which lays down structural engineering requirements (Viennese Structural Engineering Regulation 2023 – WBTv 2023)

On the basis of Sections 118(5) and 122 of the Building Code for Vienna, Provincial Law Gazette for Vienna No 11/1930, as last amended by Law Provincial Law Gazette for Vienna No. 37/2023, it is hereby decreed:

§ 1. The structural provisions in Part 9 of the Vienna Building Code are deemed as having been complied with if the guidelines of the Austrian Institute of Construction Engineering contained in the Annexes have been followed, insofar as they regulate structural engineering requirements. The exceptions are points 2.1.5 and 2.1.6 of Annex 11 and point 5 of Annex 12.

§ 2. The guidelines contained in the annexes may be deviated from if the construction applicant proves that the same level of protection is achieved as would be the case if the guidelines were applied.

§ 3. (1) Annex 10 to this Regulation serves to implement Council Directive 2013/59/Euratom of 5 December 2013 laying down basic safety standards for protection against the dangers arising from exposure to ionising radiation, and repealing Directives 89/618/Euratom, 90/641/Euratom, 96/29/Euratom, 97/43/Euratom and 2003/122/Euratom, OJ L 13, 17.1.2014, p. 1.

(2) Annexes 13 and 14 to this Regulation serve to implement Directive 2010/31/EU of the European Parliament and of the Council of 19 May 2010 on the energy performance of buildings, OJ L 153, 18.6.2010, p. 13, as amended by Directive (EU) 2018/844 of the European Parliament and of the Council of 30 May 2018, OJ L 156, 19.6.2018, p. 75.

§ 4. This Regulation has been notified in accordance with the provisions of Directive (EU) 2015/1535 of the European Parliament and of the Council of 9 September 2015 laying down a procedure for the provision of information in the field of technical regulations and of rules on Information Society services, OJ L 241, 17.9.2015, p. 1 (notification number 2023/602/AT).

§ 5. (1) This Regulation shall enter in force on the day following its proclamation. With the entry into force of this Regulation, the Regulation of the Viennese State Government laying down structural engineering requirements (Viennese Structural Engineering Ordinance 2020 – WBTv 2020), State Law Gazette for Vienna No 4/2020, is repealed.

(2) For all proceedings pending at the time this Regulation enters into force, the law in force up to that time applies.
