6. Within the framework of the notification procedure under Directive (EU) 2015/1535, the Belgian authorities notified to the Commission on 7 February 2024 the “Arrêté royal portant exécution de l'article 433quater/2 du code pénal” (hereinafter, ‘the notified draft’).

In order to allow the Commission services to complete their analysis under the relevant provisions of EU law, the Belgian authorities are kindly invited to reply to the following request for supplementary information:

The Belgian authorities are kindly requested to clarify whether the ‘suppliers’ defined in Article 1(1) of the notified draft entail on-demand audiovisual media services or video-sharing platform services as defined in Article 1(1)(g) and 1(1)(aa) of the Audiovisual Media Services Directive 2010/13/EU, as revised by Directive (EU) 2018/1808. If that is the case, the Belgian authorities are kindly requested to clarify whether the obligations included in the notified draft are also applicable to on-demand audiovisual media services or video-sharing platform services not established in the territory of Belgium.

The Belgian authorities are invited to reply by 8 March 2024.
