

Decree No 2024-760 of 8 July 2024 amending Decree No 2023-492 of 21 June 2023 on the indication of the origin of meat applicable to catering establishments offering only take away or delivery meals

Text No 7

Target audiences: consumers; managers of catering establishments offering only take away or delivery meals.

Subject: indication of the origin or provenance of meat of swine, sheep and poultry species in catering establishments offering only take away or delivery meals.

Entry into force: the text shall enter into force on the day after its publication.

Notice: this Decree extends, beyond 29 February 2024, the obligation to indicate the origin or provenance of meat of swine, sheep and poultry species in commercial and mass catering establishments without an on-site room for consumption offering only take away or delivery meals.

On the report of the Minister for the Economy, Finance and Industrial and Digital Sovereignty and the Minister for Agriculture and Food Sovereignty,

Having regard to Regulation (EU) No 1169/2011 of the European Parliament and of the Council of 25 October 2011 on the provision of food information to consumers, amending Regulations (EC) No 1924/2006 and (EC) No 1925/2006 of the European Parliament and of the Council, and repealing Commission Directive 87/250/EEC, Council Directive 90/496/EEC, Commission Directive 1999/10/EC, Directive 2000/13/EC of the European Parliament and of the Council, Commission Directives 2002/67/EC and 2008/5/EC and Commission Regulation (EC) No 608/2004, and in particular Article 44 thereof;

Having regard to Directive (EU) No 2015/1535 of the European Parliament and of the Council of 9 September 2015 laying down a procedure for the provision of information in the field of technical regulations and of rules on Information Society services;

Having regard to Decree No 2023-492 of 21 June 2023 on the indication of the origin of meat applicable to catering establishments offering only take away or delivery meals;

Having regard to notification No 2024/0112/FR addressed to the European Commission on 29/02/2024,

Hereby decrees:

Article 1

Paragraph 5 of Article 1 of the above-mentioned Decree of 21 June 2023 is deleted.

Article 2

The Minister for the Economy, Finance and Industrial and Digital Sovereignty and the Minister for Agriculture and Food Sovereignty are responsible, each one insofar as it concerns their area, for the implementation of this Decree, which will be published in the Official Journal of the French Republic.
