With the adoption of the Dairy Product Legislation Adaptation Ordinance, the four previous ordinances on butter, cheese, drinking milk and other dairy products will be replaced by one dairy product quality ordinance and the necessary consequential amendments will be made to other legislation. Due to the adaptation of the Margarine and Blends Ordinance, the Ordinance on Vitamin-fortified Foods can also be repealed. In order to ensure the quality of dairy products, the Raw Milk Quality Ordinance is amended at the same time.

9. Technological developments in the production of dairy products, as well as changes in the relevant EU legislation, require continuous updating of German dairy product legislation.
