Within the framework of the notification procedure under Directive (EU) 2015/1535 laying down a procedure for the provision of information in the field of technical regulations and of rules on Information Society services, the French authorities notified to the Commission on 21 February 2024 the "Draft decision on the list of services classified as being of general interest, pursuant to the provisions of Article 20-7 of Act No 86-1067 of 30 September 1986 on freedom of communication" (hereinafter, the "notified draft").

In order to allow the Commission services to complete their analysis under the relevant provisions of EU law, the French authorities are kindly invited to reply to the following request for supplementary information:

1. The French authorities are kindly requested to clarify the timeline and procedures for audiovisual media services under Article 1(2) of the notified draft to communicate their list of potential services of general interest to the national regulatory authority in order to benefit from the prominence scheme. Additionally, they are requested to indicate whether there will be a separate legal instrument setting out the selection criteria, including specific content requirements, for services of general interest.

2. The Commission would like to receive further information on whether it is possible for cross-border audiovisual media services provided by audiovisual media services not under the French jurisdiction pursuant to Article 2 of the revised AVMSD to classify as services of general interest within the meaning of Article 20-7 of the law of 30 September 1986 and to benefit from the prominence scheme therein.

3. The Commission would also like to ask more information from the French authorities on the number of commercial

audiovisual media service providers and their programmes under Article 1(2) of the notified draft that could benefit from the prominence scheme, in particular on any possible upper limits of this scheme.

The French authorities are kindly invited to reply by 15 March 2024.
