**Royal Order amending Annex 3 to the Royal Order of 12 October 2010 on the approval,
verification and installation of measuring instruments used to monitor the application of the
Law on Road Traffic Policing and the Orders enforcing it**

PHILIPPE, King of the Belgians,

To all those present, and those to come, Greetings.

Having regard to the Law on Road Traffic Policing, coordinated on 16 March 1968, Article 62, subparagraph 4, inserted by the Law of 4 August 1996 and amended by the Law of 9 March 2014, and subparagraph 5, inserted by the Law of 4 August 1996;

Having regard to the Code of Economic Law, Articles VIII.43(4) and VIII.46(2);

Having regard to the Royal Order of 12 October 2010 on the approval, verification and installation of measuring instruments used to monitor enforcement of the Law on Road Traffic Policing and Orders enforcing it;

Having regard to the opinion of the Inspector of Finance, issued on 5 December 2023;

Having regard to the Association of Regional Governments;

Having regard to the communication to the European Commission on (date), pursuant to Article 5(1) of Directive (EU) 2015/1535 of the European Parliament and of the Council of 9 September 2015 laying down a procedure for the provision of information in the field of technical regulations and of rules on Information Society services;

Having regard to the approval of the Secretary of State for the Budget, given on (date);

Having regard to Opinion No xxxxx/x of the Data Protection Authority given on (date);

Having regard to Opinion xxxxx/x of the Council of State given on (date), pursuant to Article 84(1), subparagraph 1, 2° of the Laws on the Council of State, consolidated on 12 January 1973;

On the proposal of the Minister for the Economy, the Minister for Mobility, the Minister for Justice and the opinion of the ministers who deliberated on them in the Council,

We have decreed and hereby decree:

Article 1. In point 2.2 of Annex 3 to the Royal Order of 12 October 2010 concerning the approval, verification and installation of measuring instruments used to monitor the application of the Law on Road Traffic Policing and the Orders enforcing it, the following amendments shall be made:

a) the sentence ‘The following necessary elements shall be visible in the image: ’ is replaced by the sentence:

‘ The following elements shall be available on the image and/or in the metadata associated with the record file: ’;

b) point 1 is replaced by the following:

‘1. the secure traffic light for each measured traffic lane or a secure indication including the time intervals for the red light or for the flashing red light at the level crossing and, where applicable, also for the amber light;’.

Article 2. The Minister for the Economy, the Minister for Mobility, the Minister for Justice, shall each be responsible for enforcing this Order.
