

**Minister for National Economy Decree No 14/2025 of 21 May 2025  
on the amendment of Minister for National Economy Decree No 2/2016 of 5  
January 2016 on the official technical and safety supervision of pressure  
equipment, filling equipment, low-power compressed gas filling equipment and  
on the periodic control of autogas tanks**

- [1] The safety conditions for the safe filling of gas cylinders for use in motor caravans at autogas refuelling stations should be defined.
- [2] On the basis of the authorisation granted in Sections 40(a) and (b) of Government Decree No 213/2019 of 27 August 2019 on the official technical and safety supervision of pressure equipment, systems and installations, and acting within the scope of my duties as defined in point 12 of Section 103(1)(12) of Government Decree No 182/2022 of 24 May 2022 on the duties and powers of members of the Government, I hereby decree the following:

- § 1** In Section 33(3)(f) of Minister for National Economy Decree 2/2016 of 5 January 2016 on the official technical and safety supervision of pressure equipment, filling equipment, low-power compressed gas filling equipment and on the periodic control of autogas tanks [hereinafter Minister for National Economy Decree No 2/2016 of 5 January 2016], the words “1 person” are replaced by the words “2 persons”.
- § 2** Annex 2 to Minister for National Economy Decree No 2/2016 of 5 January 2016 is amended in accordance with Annex 1.
- § 3** This Decree shall enter into force on the fifteenth day following its publication.
- § 4** The requirement for the prior notification of this Decree, as stipulated in Directive (EU) 2015/1535 of the European Parliament and of the Council of 9 September 2015 laying down a procedure for the provision of information in the field of technical regulations and of rules on Information Society services, has been met.

*Appendix 1 to Minister for National Economy Decree No 14/2025 of 21 May 2025*

1. Point 4.16 of Annex 2 to Minister for National Economy Decree No 2/2016 of 5 January 2016 is replaced by the following provision:

“4.16. The filling of liquefied autogas into tanks, cylinders, or transportable pressure equipment at autogas refuelling stations

4.16.1. Liquefied autogas may be transferred from a storage tank into a dedicated tank or cylinder that meets the requirements of UNECE Regulation No 67, after the engine has been stopped and the vehicle has been secured against rolling by applying the handbrake.

4.16.2. Transportable pressure equipment belonging to a motor caravan, as defined in the Regulation on the technical conditions for the entry into service and keeping in service of road vehicles, may be filled through an LPG filling device operating at an autogas refuelling station, if all of the following conditions are jointly met:

  - a) the transportable pressure equipment is equipped with a fitting to prevent the overfilling of the equipment,
  - b) the transportable pressure equipment is equipped with a safety blow-off valve,
  - c) the transportable pressure equipment bears the conformity marking set out in Annex 2 to Minister for National Economy Decree No 29/2011 of 3 August 2011 on the safety requirements and conformity certification for transportable pressure equipment;
  - d) the equivalence of the transportable pressure equipment with the pressure equipment installed in the motor caravan has been demonstrated for safe transport and use on the motor caravan,
  - e) there is no visible damage to the transportable pressure equipment,
  - f) the period of validity of the pressure test for the transportable pressure equipment has not expired at the time of filling, and
  - g) the filling valve fitted to the transportable pressure equipment is suitable for the connection of the filling nozzle.

4.16.3. In the cases specified in point 4.16.2, the filling of transportable pressure equipment at an autogas refuelling station may only be carried out by the filling station operator trained for this activity by the gas distributor.

4.16.4. The filling station operator shall refuse to fill the transportable pressure equipment if it is not demonstrated to his satisfaction that all the conditions set out in point 4.16.2 are met.”
2. Point 4.24. of Annex 2 to Minister for National Economy Decree No 2/2016 of 5 January 2016 is replaced by the following provision:

“4.24. It shall be prohibited to fill autogas into cylinders at an autogas refuelling station, except in the cases specified in points 4.16.1 and 4.16.2.”
