The Ministry of Interior Affairs and Administration (MSWiA ) has decided not to issue the Regulation of the Minister of Interior Affairs and Administration on technical conditions for protective structures and their use, notified to the European Commission on 19 July 2024 under the number 2024/0412/PL.

Regulations in this area are included in the Regulation of the Minister of Interior Affairs and Administration of 4 November 2025 on technical conditions for protective structures, their use, and location, notified under the number 2025/0629/PL (Journal of Laws, item 1548), issued pursuant to art. 115(1)(1) of the Act of 5 December 2024 on civil protection and civil defence (Journal of Laws, item 1907).

Poland is therefore withdrawing the draft Regulation and asking for the closure of the notification procedure.
