Amending and supplementing the Regulation on the Conditions and the Procedure for Registration and Identification of Participants, the Storage of Data Related to the Organised Online Betting on the Territory of the Republic of Bulgaria, and for Submission of Information on Gambling to a Server of the National Revenue Agency (NRA), adopted by Decree No. 50 of the Council of Ministers of 2021 (SG No 14 of 2021)

### THE COUNCIL OF MINISTERS HEREBY DECREES:

- **§ 1.** Article (8) shall be amended and supplemented, as follows:
- 1. The following new subparagraph (3) shall be inserted:
- "3. Data submitted by the CCS (central computer system) of an online betting organiser to a NRA server for each deposit made to the participant's gaming account in accordance with Annex 2a;".
  - 2. The former point 3 shall become point 7.
  - 3. A new point 4 shall be inserted:
- "4. Data submitted by the CCS of an online betting organiser to a NRA server for each bonus awarded to the participant's gaming account in accordance with Annex 2b:
  - 4. A new *point 5* shall be inserted:
- "5 Data that the CCS of an online betting organiser submits to a NRA server for unused bonus funds due to them being refused, partially played, expired as regards their use, or not taken by the participant (i.e. due to failure to comply with the terms and conditions thereof) according to Annex 2c"
  - 5. A new *point 6* shall be inserted:
  - "6. Data submitted by the CCS of an online betting organiser to a NRA server for cash paid into a participant's gaming account as a result of his/her use of bonus funds (subject to the conditions being successfully met) Annex 2d.
    - 6. A new point 8 shall be inserted:
- "8. Data on cancelled events to be submitted at the end of the reporting period in accordance with Annex 3a;".
  - 4. *Point* 9 shall be inserted:
- "9. Data to be submitted by the CCS of an online betting organiser to a server of the NRA for each withdrawal made from the participant's gaming account in accordance with Annex 3b."

- 5. The former point 4 shall become point 10.
- 6. The former point 5 shall become point 11 and shall be amended as follows:
- "8. Upon request data on unfinished events (active games); the data shall be submitted to a server of the NRA upon receipt of a request from the NRA and the State Agency for National Security (SANS) to the CCS of the gambling organiser in accordance with Annex 5."
  - **§ 2.** Article 9 shall be amended and supplemented, as follows:
  - 1. A new point 3 shall be inserted:
- "3. Data on cancelled events to be submitted at the end of the reporting period in accordance with Annex 7a;".
- 2. The current subparagraphs (3) and (4) *shall* become subparagraphs (4) and (5) respectively.
  - 3. The former point 5 shall become point 6 and shall be amended as follows:
- "6. Upon request data on unfinished events (active games); the data shall be submitted to a server of the NRA upon receipt of a request from the NRA and the State Agency for National Security (SANS) to the CCS of the gambling organiser in accordance with Annex 5."
  - **§ 3.** Article (11) shall be amended and supplemented, as follows:
- 1. In subparagraph (1), after the words "Annexes 1, 2", "2a", "2b", "2c", "2d" shall be added, after the word "3", "3a, 3b" shall be added, and after the words "5, 6, 7", "7a" shall be added.
  - 2. A new subparagraph (2) shall be inserted:
- "(2) The data referred to in Articles (8) and (9) shall be transmitted to a NRA server in EET/EEST (i.e. Bulgarian time)."
- 3. The former subparagraph (2) shall become subparagraph (3), with the addition of "2a", "2b", "2c", "2d" after the words "Annexes 1, 2", "3a, 3b" after the word "3", and "7a" after the words "5, 6, 7".
- 4. The former subparagraphs (3) and (4) shall become subparagraphs (4) and (5) respectively.
  - **§ 4.** Article (14) shall be amended and supplemented, as follows:
  - 1. The current text shall become subparagraph (1).
  - 2. New subparagraph (2) shall be inserted:
- "(2) The messages sent and received confirmations from the NRA server are stored on a mirror copy and in the local control server of the gambling organiser within the same period."
  - **§ 5.** Article (15) shall be amended and supplemented, as follows:
  - 1. A new subparagraph (4) shall be inserted:
- "(4) Access to the local control server (LCS), the content of the reports, and the selection criteria for generating them shall be provided from a single IP address assigned by the NRA, from which the employees designated by order of the NRA's Executive Director shall access the LCS of the organiser."
  - 2. New subparagraph (5) shall be inserted:
- "(5) Access under subparagraph (3) shall be granted to the revenue authorities in the course of control proceedings carried out to ensure compliance with the provisions of the Gambling Act and this Regulation."
  - 3. The current subparagraph (4) shall become subparagraph (6).

### **§ 6.** Article (15a) shall be inserted:

"Article 15a. When a control bet is placed by or under the supervision of a NRA authority, after legitimising the NRA authority and indicating the specific gaming sessions subject to a control bet to the gambling organiser, the organiser shall return the deposited amount to the NRA's account and cancel the gaming sessions performed during the control bet.

- § 7. The title of Chapter Five shall be amended as follows: "Conditions and procedure for the approval of systems of gambling organisers for the automated submission of information on gambling to a NRA server".
  - **§ 8.** Article (20) shall be amended and supplemented, as follows:
- 1. In subparagraph 1, the words "for gambling" shall be added after the words "submission of information" and the word "organisers" shall be replaced by "persons".
  - 2. A new subparagraph (3) shall be inserted:
- "(3) The request referred to in subparagraph 1 shall be accompanied by a test report declaring compliance with the requirements of the regulations referred to in Article 17(3)(2) and/or (4) and/or (6) of the Gambling Act of the specified CCS by an accredited laboratory listed in the register in accordance with Article 20(1)(4) of the Gambling Act, and a description of the system indicating the functionality of its main components."
- 3. The former subparagraphs (3) and (4) shall become subparagraphs (4) and (5) respectively.
  - **§ 9.** Article (21) shall be amended and supplemented, as follows:
- 1. In subparagraph (4), after the words "the regulation or the Gambling Act", the words "as well as in the case of discrepancies found in the course of testing the systems of gambling organisers" shall be added.
- 2. In subparagraph (7), the words "failure to comply with the obligation referred to in paragraph 4 on the part of the applicant" shall be replaced by "non-remediation of the discrepancies by the applicant in accordance with the procedure and within the time limit laid down in subparagraph (4)".
  - **§ 10.** Article (22) shall be amended and supplemented, as follows:
  - 1. The former text shall become subparagraph (1) and in it the words "subparagraph (1) for approval of changes in the functionality" shall be added after the words "Article (20)" and the words "while to the request the updated documentation of the system shall be attached and the reasons for the change shall be indicated" shall be deleted.
    - 2. The following subparagraphs (2) and (3) shall be inserted:
  - "(2) The request shall be accompanied by documentation, including a test report stating compliance with the requirements of the regulations referred to in Article 17(3)(2) and/or (4) and/or (6) of the Gambling Act of the said CCS by an accredited laboratory entered in the register in accordance with Article 20(1)(4) of the Gambling Act, and a description of the system, indicating the functionality of its modified components. The request shall be examined in accordance with the procedure and within the time limits laid down in Article (21).
  - (3) The refusal to approve the change in the functionality of the systems for automated submission of information to a NRA server may be appealed under the Administrative Procedure Code."

### **§ 11.** In Chapter Five, Article (23) shall be inserted:

- "Article 23. (1) For the purposes of automated data submission to the NRA server, the organisers shall be obliged to submit an application form to the Executive Director of the NRA in the event of a change related to an increase or replacement of gaming software.
- (2) The application shall be submitted in cases where the increased/replaced gaming software is from a new manufacturer from whom no gaming software has been registered until the change in the license certificate of the organiser.
- (3) The application referred to in subparagraph (1) shall be submitted within 14 days of receipt by the organisers of the new certificate with a registered change relating to an increase or replacement of the gaming software, on the basis of the final decision authorising the change referred to in Article (38) of the Gambling Act.
- (4) Within 10 days of the submission of the application, it shall be verified whether the CCS/LCS automatically submits data to the NRA server from the upgraded/replaced gaming software, for which a report shall be drawn up and submitted to the organiser.
- (5) In cases where a discrepancy is found in the automated submission of data from the CCS/LCS to the NRA server in relation to the upgraded/replaced software, the Executive Director of the NRA may order the suspension of the use of the upgraded/replaced software until the discrepancy has been remedied."

### **§ 12.** A new point 3 shall be inserted in § 1 of the additional provision:

"3. "A change in the functionality of the systems for automated submission of information to a server of the NRA" means any change in the version and/or modification of the CCS/LCS resulting in a change in the automated submission of data to a server of the NRA.

#### **§ 13.** Annex 1 shall be amended as follows:

- 1. In the table under point 1 "Data submitted by the CCS of each online betting organiser to a NRA server", in the row "Date of generation of the report", in the column "Control of the item", the words "EET/EES time zone" shall be added after the words "Format 2010-02-16T16:47:31".
- 2. In the table under point 2 "Notification-confirmation message sent by a NRA server for data received upon registration, modification of data or deregistration of an online betting organiser":
- (a) in the row "Type of confirmation" in the column "Explanation", "8 Cancellation of game data" shall be added at the end;
  - (b) in the row "Operation status":
  - (aa) in the column "Clarification", the following shall be added at the end:
  - "4 The organiser has not been found
  - 5 The field may not be subject to a change
  - 6 The organiser has been deregistered
  - 7 The licence has not been found";
- (bb) in the column "Control", the following shall be added: "A complete list of the return statuses of an operation is set out in the XSD data exchange scheme published on the NRA website, in accordance with the requirements of the Regulation on the conditions and the procedure for registration and identification of participants, the storage of data related to the organised online betting on the territory of the Republic of Bulgaria, and for submission of information on gambling to a server of the National Revenue Agency".

### **§ 14.** Annex 2 shall be amended as follows:

1. In the table under point 1 "Data that the CCS of an online betting organiser submits in online mode to a NRA server upon initial registration or upon change of the registration data of each participant in online betting", in the row "Date of generation of the report", in the

column "Control", after the words "Format 2010-02-16T16:47:31", the words "EET/EEST time zone" shall be added.

- 2. In the table under point 2 "Notification-confirmation message sent by a NRA server for received data on the registration or change of the registration data of a participant in a gambling game":
- (a) in the row "Type of confirmation" in the column "Explanation", "8 Cancellation of game data" shall be added at the end;
  - (b) in the row "Operation status":
  - (aa) in the column "Clarification", the following shall be added at the end:
  - "4 The organiser has not been found
  - 5 The field may not be subject to a change
  - 6 The organiser has been deregistered
  - 8 The participant has been already registered
  - 9 The participant has not been found
  - 10 The participant has been deregistered";
- (bb) in the column "Control", the following shall be added: "A complete list of the return statuses of an operation is set out in the XSD data exchange scheme published on the NRA website, in accordance with the requirements of the Regulation on the conditions and the procedure for registration and identification of participants, the storage of data related to the organised online betting on the territory of the Republic of Bulgaria, and for submission of information on gambling to a server of the National Revenue Agency".
  - **§ 15.** In Article 8(3), the following Annex 2a shall be inserted:

### **Transitional provision**

- § 26. (1) Within nine months of the entry into force of the Decree, the gambling organisers shall bring the functionalities of their systems into line with the requirements of this Decree and shall submit a request in accordance with Article 22(1) of the Regulation.
- (2) Compliance testing shall be carried out on the request referred to in paragraph 1, on the basis of which the Executive Director of the National Revenue Agency shall issue a decision approving or refusing to approve the systems for automated submission of information to the server of the National Revenue Agency.-
- (3) Until an approval decision under paragraph 2 has been issued, the organisers shall submit the information to the server of the National Revenue Agency in accordance with the previous procedure.
- (4) The pending proceedings under Article 20(1) of the Regulation at the time of the entry into force of this Decree shall be suspended until the functionalities of the organiser's system have been brought into line with the requirements of the Decree.
