The aim of the draft Belgian Cooperation Agreement is to establish a national legislative framework with regard to certain waste streams subject to extended producer responsibility, as provided for in Directive (EU) 2019/904 on the reduction of the impact of certain plastic products on the environment. However, the scope of the Belgian project does not comply with the requirements of Directive (EU) 2019/904 and also constitutes a potential obstacle to the smooth functioning of the EU internal market.

The Belgian draft legislation requires manufacturers and importers of tobacco products with filters to pay Extended Producer Responsibility (EPR) fees, whether or not the products have a filter and, accordingly, whether they contain plastic or not. This is not in line with Articles 7 and 8 of Directive (EU) 2019/904, which require measures to reduce the consumption of and market constraints for products containing plastic. Moreover, recital 16 of Directive (EU) 2019/904 explicitly states that "Innovation and product development are expected to provide viable alternatives to filters containing plastic and need to be accelerated. Extended producer responsibility schemes for tobacco products with filters containing plastic should also encourage innovation leading to the development of sustainable alternatives to tobacco product filters containing plastic. Member States should promote a wide range of measures to reduce litter from post-consumption waste of tobacco products with filters containing plastic.". In general, Directive (EU) 2019/904 aims to promote the development and use of available and more sustainable alternatives to plastic products.

As a result of the Belgian legislative proposal, investments in research and development for plastic-free tobacco filter solutions, as well as their potential production, will be rendered meaningless and severely affected. By not distinguishing whether tobacco products are filtered, contain plastic or not, the Belgian proposal also creates potential future obstacles to the introduction of goods on the Belgian market and the unimpeded movement of goods within the EU, which would lead to an infringement of Article 34 of the Treaty on the Functioning of the European Union, prohibiting national measures having the effect of similar to quantitative restrictions on imports. Imposing the same amount and disproportionate levies on both plastic-containing and non-plastic tobacco products with filters makes huge investments in developing sustainable alternatives – plastic-free filters, meaningless – and the prices of tobacco products with non-plastic filters will be uncompetitive to those with current cellulose acetate filters. This will create conditions for unfair competition and failure to achieve the objectives of Directive (EU) 2019/904.

In conclusion, we consider that a Belgian draft law to be adopted contains provisions that are not in line with the provisions and main objectives of Directive (EU) 2019/904, they are disproportionate and pose a serious risk of unjustified obstacles to the free movement of goods in the internal market and distortion of competition. It is important to note that though each Member State is free to decide how to transpose the Directive into its national legislation, the EU regulatory framework aims to harmonise the rules, ensure transparent and efficient application of European rules, and ensure proportionate legislative acts, as an objective of the Better Regulation agenda.
