Within the framework of the notification procedure laid down by Directive (EU) 2015/1535, the Belgian authorities notified to the Commission on 2 October 2023 the “Preliminary draft law amending the Law of 7 May 1999 on games of chance, betting, gambling establishments and the protection of players” (hereinafter, ‘the notified draft’).

In order to allow the Commission services to complete their analysis under the relevant provisions of EU law, the Belgian authorities are kindly invited to reply to the following request for supplementary information:

“Has the Ministry of Justice conducted a data protection impact assessment and if not do they plan to do so in the near future? Have they consulted the Belgian Data Protection Authority and if yes has the Data Protection Authority published an opinion?”
